#### Role Summary

1. Lead regional partnerships and oversee the rollout of Khan Academy and Khanmigo AI programs across Government, NGO-run, and Private school networks.
2. Act as the primary liaison with Education Ministries to align project implementation.
3. Build strong collaboration with development agencies promoting EdTech in the education sector.
4. Ensure effective school onboarding, and continuous student engagement through data-driven monitoring and support.
5. Identify, pursue, and manage donor-funded opportunities and partnerships across the assigned region.
6. These roles require regular travel within the city and surrounding region.

#### Key Responsibilities

- **Program Implementation & School Onboarding:** Lead the rollout and implementation of Khan Academy and Khanmigo AI programs across schools in the region; ensure all schools are properly set up and active on Khan Academy platforms.
- **Partnerships & Stakeholder Engagement:** Build and maintain strong relationships with government bodies, development partners, and school networks; represent KAP in meetings and coordination forums.
- **Teacher Training & Capacity Development:** Coordinate with KAP's Academic and Training teams to deliver hybrid teacher training programs; track participation, engagement, and follow up on outcomes.
- **Monitoring, Data & Reporting:** Collaborate with the Data Intelligence team to monitor KPIs, track progress, and document best practices and success stories.
- **Communications & Representation:** Serve as the regional spokesperson; support visibility campaigns and showcase regional achievements.

- **Donor Funding & Reporting:** Identify and engage donor organizations; secure funding and share periodic updates on fund utilization to demonstrate impact on teaching quality and student learning.
- **Representation & Coordination:** Represent KAP in meetings with school partners, donors, and regional stakeholders to strengthen collaboration and alignment.
- **First 30 Days:** Orientation on KAP programs; establish stakeholder contact; review regional school data.
